The members present at a duly called or held meeting at which a quorum is present may continue to do business until adjournment, notwithstanding the withdrawal of enough members to leave less than a quorum."

- 2. Ratification. All other provisions of the Declaration, as amended, shall remain unchanged and in full force or effect, except as specifically amended herein.
- Counterparts. This Amendment may be executed in any number of counterparts such that 3. the original signature pages, when combined, shall constitute a complete and binding Amendment.
